

# Mint Asset Management Funds Mint Diversified Income Fund

Fund Update for the quarter ended 30 June 2021

This Fund Update was first made publicly available on 28 July 2021

#### What is the purpose of this update?

This document tells you how the Mint Diversified Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mint Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The Fund has a broad mandate which permits investments into New Zealand and international fixed interest, cash and cash equivalents, Australasian and international equities and listed property. The objective of the Fund is to deliver a total return (through a combination of income and capital growth) in excess of the Consumers Price Index (CPI) by 3% per annum, before fees, over the medium to longterm. The relevant market index for the Fund is a composite index derived from the underlying asset classes of the Fund that make up the Fund's Strategic Asset Allocation.

#### What are the risks of investing?


The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


#### How has the fund performed?

# **Annual Return Graph**



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2021.

#### Example of how this applies to an investor

Annie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Annie recieved a return after fund charges were deducted of \$863 (that is 8.63% of her initial \$10,000). Annie did not pay any other charges. This gives Annie a total return after tax of \$780 for the year.

The fund's exposure to assets denominated in foreign currencies was 30% of which 92% was hedged back to NZD.
